

## **Oakley City Facility Rental Agreement**

## **ADDITIONAL FEES:**

- A <u>\$500 security deposit</u> is required to be paid the week of your event. Your security deposit will be refunded within 3-5 business days pending any damage to the facility, noise complaints, and clean-up issues.
- A **\$75 fee** will be charged to your card if we must meet after business hours to issue a key.
- A **\$50 fee** will be charged to tour the facility after business hours.
- A <u>\$75 fee</u> will be charged if the key is not returned within 2-days of the event. (The key may be left in the mailbox on the east side of Oakley City of after the event.)
- Oakley City's Cancellation Policy is as follows: Cancellations received up to three months before your
  event receive 50% refund of the rental fee. Cancellations received less than three months prior to your
  event means forfeiting the entire rental fee.
- -The rental for the facility is for the full day from 6 a.m. to 11:59 p.m. Your event must end in time to properly clean the facility and be out by 11:59 p.m. NOTE: All music must cease by 10:00 p.m.
- -The renter must be 21 years of age or older and show legal proof of residency for the local or Kamas Valley resident rate.
- -Oakley City is not responsible for any lost or stolen items.
- -Oakley City will remain free and harmless from any liability claims that may occur.
- <u>-DAMAGE</u>: The renter is financially responsible for during the use of the facilities because of the activities of the renter and guests.
- -CLEANING: The renter is responsible for properly cleaning the facility by checking ALL items on the provided cleaning list. Failure to properly clean the facility will result in forfeiture of a portion or all of your security deposit. Notify Oakley City of any damage so that it may be repaired in a timely manner.
  Damages caused during your rental will result in forfeiture of a portion or all of your security deposit.
- -NUISANCE/NOISE COMPLAINTS: Renters will respect the rights of adjacent residents and behave in a manner that does not create a nuisance to surrounding residents and properties. This includes, but is not limited to, playing loud music that reverberates outside of the building. If a complaint is received and "verified," the renter forfeits their full security deposit. If a noise complaint is received, Oakley City staff will ask you and your guests to vacate the premises and includes placing the renter on a "DO NOT RENT TO" list for all future requests.
- -Oakley City reserves the right to refuse future service to renters who violate the rules of the rental agreement in any way.
