


RESOLUTION 2022-04

**A RESOLUTION AMENDING THE CONSOLIDATED FEE SCHEDULE FOR OAKLEY CITY, UTAH.**


**Section 1.** Whereas Oakley City has established a Consolidated Fee Schedule for the purpose of collecting necessary fees for goods and services rendered by the City;
